Author Agreement

Between

the Editors of the Journal of Service Management Research

– hereinafter referred to as the Editors –

and

...

– hereinafter referred to as the Authors –

the following agreement is concluded:

§1 Subject Matter of the Agreement

(1) The subject matter of this agreement is the storage and publication of a contribution (including the abstract) in the scholarly open access Journal of Service Management Research.

(2) The title of the contribution is ...

§2 Form of Publication

(1) The contribution will be published digitally as a downloadable PDF and, where applicable, in additional issue formats (e.g., HTML, XML, EPUB) as an open access publication.

(2) As a rule, the Authors do not pay any fees for the publication of their contribution (e.g., article processing charges).

(3) The Authors will not receive any remuneration.

§3 Grant of Rights

(1) The Authors hold the copyright in their contribution and grant the Editors, for an unlimited period of time, free of charge and irrevocably, the simple (non-exclusive) and permanent right of electronic storage, making publicly available, distribution, reproduction, and archiving of their contribution.

(a) The Editors are entitled to publish and reproduce the contribution digitally and to make it freely accessible in digital form via national and international data networks.

(b) Where necessary, the Editors are permitted to convert the data into other formats if required by technological developments. The digital publication will be archived on the internet for as long as this is technically feasible with reasonable effort.

(2) The Authors agree that their contribution will be published under the Creative Commons Attribution 4.0 International licence (CC BY 4.0)

(3) The Authors agree that the metadata for their contribution will be published under the Creative Commons CC0 1.0 Universal Public Domain Dedication

(<https://creativecommons.org/publicdomain/zero/1.0/legalcode>).

(4) The Authors warrant that third-party works (e.g., figures) that are not themselves subject to the Creative Commons Attribution 4.0 International licence (CC BY 4.0)

(<https://creativecommons.org/licenses/by/4.0/legalcode>) are identified by separate licensing information.

(5) The Editors do not warrant that the publications they publish pursuant to this agreement are free of third-party rights. If such rights become known to the Editors, they will inform the Authors accordingly.

(6) The Authors undertake to indemnify the Editors against such third-party claims as arise from the fact that, due to culpably incorrect statements by the Authors regarding the non-existence of third-party rights or other circumstances for which they are responsible, the publication of the work results in an infringement of copyrights or exclusive rights of use. This shall not apply if the infringement is based on intentional or grossly negligent conduct on the part of the Editors and the Authors are not similarly culpable through intent or gross negligence.

(7) The liability of the Editors for slightly negligent breaches of duty is excluded. The liability of the Editors for grossly negligent breaches of duty is limited in amount to the foreseeable damages typical for the contract at the time of conclusion of the contract. In the latter case, the damages shall be allocated taking into account, in particular, the respective degrees of fault.

(8) The liability of the Editors for indirect damages, in particular consequential damages and loss of profit, is excluded.

(9) The aforementioned limitations of liability and/or exclusions shall also apply to the legal representatives and vicarious agents of the parties.

(10) The Authors undertake to comply with the DFG "Guidelines for Safeguarding Good Research Practice".

(11) The Authors shall disclose in a clear and transparent manner any use of AI tools in the creation of content submitted with the work, indicating which parts were AI-generated or AI-assisted, which tools were used, and how they were used. This obligation also applies to non-published materials (e.g., abstracts, proposals) and to any AI use in the publication production

process. The Authors remain fully responsible for the entire work, including AI-assisted parts, in particular for accuracy, originality, proper citation, and compliance with good research practice and the ethical principles of scholarly publishing.

§5 Term of the Agreement

(1) This agreement takes effect on the date it is signed by the Editors and the Authors. The term of the agreement is indefinite.

(2) Amendments or supplements to this agreement must be made in writing.
